NON-FUEL ROUGH PRODUCTION COST EQUALIZATION ADJUSTMENT RIDER

I. GENERAL

This Non-Fuel Rough Production Cost Equalization Adjustment Rider ("Rider NFRPCEA") defines the procedure by which Entergy Gulf States, Inc. ("Company") shall treat the non-fuel portion of Rough Production Cost Equalization Remedy Receipts.

II. APPLICABILITY

This Rider is applicable under the regular terms and conditions of the Company to all Customers served under applicable retail electric rate schedules, whether metered or unmetered, and/or rider schedules subject to the jurisdiction of the Louisiana Public Service Commission ("LPSC" or "Commission").

III. TERM

Rider NFRPCEA shall be effective starting with the first billing cycle for June and continuing through the final billing cycle for December each year, beginning in 2007.

IV. ADJUSTMENT FACTORS

The Adjustment Factors billed in accordance with Rider NFRPCEA shall be set forth in Attachment A to this Rider NFRPCEA.

V. TRUE UP

Any over or under recovery through Rider NFRPCEA including carrying costs will be added to the fuel adjustment in the March billing month of the following calendar year.

ADJUSTMENT FACTORS

The Adjustment shall be effective for the billing months of June through December, starting with the first billing cycle of June 2011 billing month. Amounts billed pursuant to this Rider NFRPCEA are subject to State and Local sales tax.
